The Use of Social Media

In today's digital age, social media has become a significant part of many pupils' daily lives. While these platforms can offer opportunities for creativity, communication, and connection, they also present a variety of challenges that impact not only our pupils' well-being but also the school environment.

We want to take this opportunity to outline our school's stance on social media use, the potential risks associated with it, and how we handle issues that arise from online behaviour.

Whilst we recognise that social media use largely occurs outside of school hours, its impact sometimes finds its way into our classrooms, corridors, and pupils' lives. Incidents that originate on social media, such as cyberbullying, inappropriate content sharing, or online conflicts, can disrupt the learning environment and affect our children emotionally and academically.

Smestow Academy takes these matters seriously. Even when social media interactions occur outside of school, if they negatively impact the wellbeing of pupils or the school environment, we will address these issues promptly in collaboration with parents and, if necessary, appropriate authorities.

To ensure the safety and well-being of our pupils, we have established clear guidelines for handling incidents related to social media:

- **Cyberbullying or Harassment:** If a pupil is involved in cyberbullying—whether as the victim, perpetrator, or bystander—we will take swift action in line with our anti-bullying policy. This includes addressing online behaviour that causes harm to another child, even if it happens outside of school hours.
- **Inappropriate Content:** Sharing inappropriate or harmful content, such as explicit images, videos, or offensive language, is strictly against our school's values. Any pupil found participating in such activities will face consequences that may include parental involvement, and, in serious cases, law enforcement.
- **Online Conflicts:** Conflicts that arise on social media platforms but affect pupils' relationships at school will be treated with the same seriousness as face-to-face disputes. We encourage pupils to seek support from trusted adults when conflicts occur, and we work to mediate these issues before they escalate.
